again and was able to reach inside and unlock the door. We then again gave the defendant several verbal commands to step out. The defendant tensed up and stated "nope nope nope I'm not getting out, get your hands off of me". The Defendant refused to step out leaving us no choice but to pull him out of the vehicle.

Once we were able to get the Defendant out of the vehicle, we attempted to place him in handcuffs. The Defendant tensed up and refused to comply with my commands. At that point the Defendant fell on his knees and refused to place his hand behind his back. I again attempted to place his hand behind his back and he refused and tensed up. I then with a closed fist struck the Defendant three times in the upper shoulder area. The Defendant continued refusing and at that point Deputy Mendez gave the Defendant a knee strike which was immediately effective and we were able to place the Defendant into handcuffs.

The defendant was later identified by his FL DL as Steven Richard Meadows. Broward Fire rescue (run#3450) responded to treat the Defendant for his facial injuries. The vehicle was removed by Emeralds towing. The defendant was transported to Pompano Beach interview room by Deputy Navarro CCN-15480 transported the defendant from the scene to Pompano Beach Station. While there, the defendant complained about having chest pain. Pompano Beach Fire Rescue responded (run#9911) and transported the defendant to Holy Cross Hospital for further evaluations.

The Defendant had a Garmin dash camera in his vehicle, which was recording the indecent. The camera was submitted into evidence. Deputy Mendez suffered bruising and redness/swelling in both of his inner forearm. The Defendant had swelling to the right
