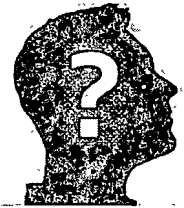

The vehicle came to complete stop in the lane next to me impeding the flow of traffic. Again I attempted to see who was in the vehicle but the window tints were to dark. The vehicle then took off at a fast pace heading northbound on turnpike. I then proceeded to make a traffic stop. The final stop was on turnpike just north of commercial Blvd on the right shoulder.

The vehicle is a 2013 white ford van bearing a FL tag of 478TFJ. Due to the vehicle having dark tints and the vehicle's suspicious actions, I positioned my vehicle in a safe distance behind him with my police lights activated as I waited for backup Deputies.

Once Deputy Mendez CCN#17800 arrived on scene the Defendant slowly drove off. I then positioned my vehicle next to him and ordered him to stop. The Defendant then came to a complete stop. I exited my vehicle and gave the defendant several verbal commands to stop the vehicle. The defendant had his driver window down as I approached and began attempting to close the window. At that point with my two hands I held the window down and gave the defendant several commands to stop and step out of the vehicle. The Defendant then grabbed both of my hands and pushed them off. I then attempted to open the door but it was locked. The defendants continued refusing to open the door. At that point I reached inside his vehicle to unlock the door and again the Defendant grabbed my hand and pushed it out stating "don't touch me".

Deputy Mendez while attempting to reach inside his vehicle, the Defendant grabbed Deputy Mendez left arm in and forcefully pushed it off. Deputy Mendez then attempted

FORT LAUDERDALE, FL 33-319 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

again and was able to reach inside and unlock the door. We then again gave the defendant several verbal commands to step out. The defendant tensed up and stated "nope nope nope I'm not getting out, get your hands off of me". The Defendant refused to step out leaving us no choice but to pull him out of the vehicle.

Once we were able to get the Defendant out of the vehicle, we attempted to place him in handcuffs. The Defendant tensed up and refused to comply with my commands. At that point the Defendant fell on his knees and refused to place his hand behind his back. I again attempted to place his hand behind his back and he refused and tensed up. I then with a closed fist struck the Defendant three times in the upper shoulder area. The Defendant continued refusing and at that point Deputy Mendez gave the Defendant a knee strike which was immediately effective and we were able to place the Defendant into handcuffs.

The defendant was later identified by his FL DL as Steven Richard Meadows. Broward Fire rescue (run#3450) responded to treat the Defendant for his facial injuries. The vehicle was removed by Emeralds towing. The defendant was transported to Pompano Beach interview room by Deputy Navarro CCN-15480 transported the defendant from the scene to Pompano Beach Station. While there, the defendant complained about having chest pain. Pompano Beach Fire Rescue responded (run#9911) and transported the defendant to Holy Cross Hospital for further evaluations.

The Defendant had a Garmin dash camera in his vehicle, which was recording the indecent. The camera was submitted into evidence. Deputy Mendez suffered bruising and redness/swelling in both of his inner forearm. The Defendant had swelling to the right

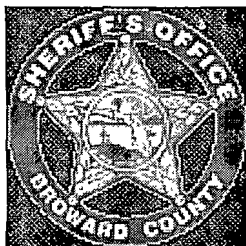

At that point with my two hands I held the window down and gave the defendant several commands to stop and step out of the vehicle. The Defendant then grabbed both of my hands and pushed them off. I then attempted to open the door but it was locked. The defendants continued refusing to open the door. At that point I reached inside his vehicle to unlock the door and again the Defendant grabbed my hand and pushed it out stating "don't touch me".

Deputy Mendez while attempting to reach inside his vehicle, the Defendant grabbed Deputy Mendez left arm in and forcefully pushed it off. Deputy Mendez then attempted

At that point the Defendant fell on his knees and refused to place his hand behind his back. I again attempted to place his hand behind his back and he refused and tensed up. I then with a closed fist struck the Defendant three times in the upper shoulder area. The Defendant continued refusing and at that point Deputy Mendez gave the Defendant a knee strike which was immediately effective and we were able to place the Defendant into handcuffs.

The defendant was later identified by his FL DL as Steven Richard Meadows. Broward Fire rescue (run#3450) responded to treat the Defendant for his facial injuries.
