C A U S E	On 04/06/2022 at approximately 0052 hours, this Officer was conducting speed measurement enforcement in the area of the 13500-block of ALT A1A, PBG, FL, when a vehicle was observed traveling at an increased rate of speed south bound. Body worn camera and in car video were used in the investigation.								
	This Officer's initial visual estimation of the vehicle, was 75 MPH in a posted 50 MPH zone. Using RADAR Stalker DSR2X (DB001317), front antenna (KC086606) this Officer received a steady tone and reading of 75 MPH. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer entered the lane behind the vehicle, a two door Jaguar sedan (05ATYA/FL) and observed the vehicle disregard a steady red light at the intersection of Alt A1A and Hood Rd, PBG, FL, while making a left-hand turn. These actions, between the excessive speed and disregarding a steady red light, were perceived by this Officer to be a clear wanton disregard for others and property.								
M E M O R A N D U M	This Officer initiated a traffic stop on same just north of the entrance of the Frenchmans Reserve community. This Officer made contact with the driver, identified via Florida Driver License photo, Steven Lowson (OF) while he was still in actual physical control of the vehicle. Lowson had low droopy eyes, slow slurred speech, glassy watery eyes, and the obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. The odor increased as Lowson spoke. Lowson immediately said "I live here". Lowson further stated he was coming from a company event and Lowson denied consuming alcohol on this night.

in Standardized Field Sobriety Exercises, to which he complied. Lowson said he did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3 with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Lowson also had the onset of Nystagmus prior to 45 degrees in both eyes. During the exercise Lowson was not following instructions until being reminded to do so. Lowson also interrupted the exercise and asked to go home, this Officer then advised Lowson of his Taylor Warnings. Lowson agreed to continue the exercise, which is when this Officer made the aforementioned observations. The second exercise conducted, was the Walk and Turn. The line used, was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Lowson lost his balance and exited the starting position. Lowson then stepped out of the starting position and claimed to not understand and asked what his rights were. Lowson then had to be advised once again of his Taylor Warnings. Lowson again agreed to continue the exercise. During the first set of steps, Lowson, stepped off the line after his first and second steps respectively. Lowson also raised his arms more than six inches from his sides and paused multiple times after stepping. Before the return set of steps, Lowson had to pause and regain his composure. Lowson again raised his arms more than six inches from his sides during the return. Lowson also mentioned wearing boots and was given the opportunity to remove them and try again, to which he refused. Between exercises, Lowson began talking in circles and repeating himself. Lowson had to be told the same information repeatedly. The third and final exercise was the One-Leg Stand. During the exercise, Lowson raised his left foot. Lowson swayed and raised his arms more than six inches from his sides. Lowson placed his left foot down twice and was not counting aloud. Lowson then paused and regained his composure before raising his right foot. Lowson again swayed, raised his arms more than six inches from his sides and placed his foot down. Since Lowson had dropped his foot three times, the exercise was ended early. Based on this Officers observations and the totality of the circumstances, Lowson was placed under arrest at 0113 hours. At PBSO BAT, this Officer requested Lowson provide a breath sample for the purpose of determining its alcohol content to which he refused. This Officer read Florida Implied Consent to Lowson, to which he interrupted and requested counsel. This Officer read Florida Implied Consent again, from the beginning, to Lowson, to which he claimed to not understand without counsel. This Officer accepted this as Lowson being uncooperative and thus refusing at 0210 hours.

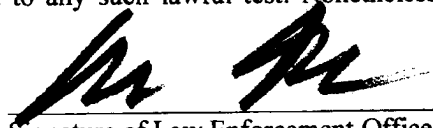

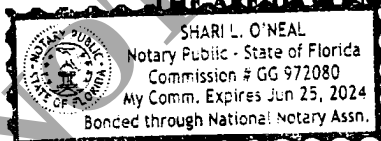

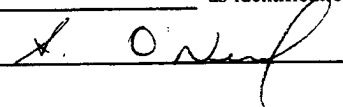
