The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a gray 2010 Nissan Altima, 4 door, Florida tag LGGZ86. The defendant drove his vehicle in a manner in which he drifted in the travel lane, crossed onto and over painted lane markers several times, swerved once, and drove at excess speeds on wet roadways. The defendant drove at speeds of up to 78 MPH in posted 50 MPH and 55 MPH speed limits (visually estimated and patrol car TPD unit 5153 paced). A traffic stop was conducted for the unlawful speed violation as well as to check on the driver's condition to determine if he were sick, tired, distracted, or impaired. The defendant stopped so that the left side of his vehicle was less than one foot from the outside solid lane line, forcing me to walk into the outer lane of interstate traffic in order to make a driver side approach. The defendant fumbled with his wallet and other documents, was forgetful as to what documents had been requested, and had difficulty multi-tasking such as looking for documents and answering questions. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and his speech was somewhat slurred. The defendant denied consuming any alcoholic beverages. The defendant was unsteady as he exited the vehicle, had difficulty following instructions as he stood in the outer interstate traffic lane rather than moving to the side as instructed. The defendant's stance was slightly wobbly and he swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant refused to submit to a lawful breath test after being advised of the Implied Consent Warnings. The defendant has a documented (DAVID and DHSMV) refusal to submit to a lawful test of his breath, urine, blood.
