On the above date and time, I, Trooper Lampiasi ID 16492 responded to a call from dispatch regarding a reckless vehicle. Dispatch stated large white truck bearing FL Tag LKQC12 was traveling southbound on SR-91, Florida's Turnpike. Dispatch

stated the vehicle almost hit a wall while entering the turnpike and almost flipped over. Dispatch stated the vehicle was varying speed from 65mph-95mph.

Trooper Keubler ID 1337 found the vehicle traveling southbound around mile post 108 in Palm Beach County, Florida. Tpr. Keubler observed the vehicle's driving pattern for some time until the vehicle reached my position (see his dash-cam video). The vehicle was traveling within the right outside lane when I observed the vehicle. While observing the vehicle, I observed the vehicle's right tires straddling the right white lane lane. The vehicle was weaving within it's lane of travel at approximately 70mph.

At that time, due to the vehicle's reported driving pattern and my visual observation of the vehicle driving, I initiated a welfare stop on the vehicle. The vehicle pulled over to the right shoulder when I activated my emergency lights. As I approached the driver side window I made contact with driver, identified via his FL DL as Steven W. Gable. Mr. Gable appeared to have glassy/watery eyes. I immediately smelled the odor of an unknown alcoholic beverage emitting from within the vehicle. I advised Mr. Gable the reason why I conducted a traffic stop on him. I requested Mr. Gable's FL DL, registration, and insurance. Mr. Gable had a difficult time gathering and finding his documents. Mr. Gable had the odor of an unknown alcoholic beverage coming from his breath as he spoke. Mr. Gable stated he was traveling "south". Mr. Gable denied consuming any alcohol when asked. Mr. Gable was slow to respond to questions and had slurred, thick speech. I ran Mr. Gable via FCIC/NCIC which came back with a valid response.

At that time, due to Mr. Gable's driving pattern and personal interaction, I requested Mr. Gable to participate in Standardized Field Sobriety Tasks (SFST's). Mr. Gable agreed to participate in SFST's when requested. As Mr. Gable exited the vehicle, he appeared to be unbalanced. Mr. Gable performed poorly on all SFST's (see dash-cam video when available and fully completed DUI packet for detailed notes).

Due to Mr. Gable's driving pattern, personal interaction, and SFST performance, I concluded that Mr. Gable's normal faculties were impaired at the time he operated

his motor vehicle. Mr. Gable was arrested for Driving Under the Influence at 2036 hours. Mr. Gable was handcuffed (double locked) and placed in the rear of my patrol vehicle. Mr. Gable's vehicle was inventoried as it was being towed. Within Mr. Gable's vehicle was approximately three (3) opened/emptied cans of beer.

Mr. Gable was transported to the Palm Beach County Jail without incident. While at the jail, Mr. Gable became verbally aggressive and started yelling. Mr. Gable started cursing and said some of the following: "You think I'm ashamed to say the word niger" "You're a skinny dwebe" "You're probably on your knees sucking dick" and "Do you ever get pussy?". I requested Mr. Gable to provide a sample of his breath. The entire time I attempted to speak, Mr. Gable kept speaking over and cursing. When I asked Mr. Gable to provide a sample, he stated "Fuck you". I read Mr. Gable implied consent and he continued cursing (see PBSO BAT Video). Due to Mr. Gable cursing and not responding, I concluded that Mr. Gable refused to submit to a sample. As per FCIC, Mr. Gable has a prior refusal to submit to a lawful test of breath, urine, or blood. Mr. Gable was charged with refusing to submit to a lawful test after previously being suspended for a refusal. Mr. Gable was transferred into the custody of the Palm Beach County Sheriff's Office for booking.
