On May 10th, 2017, at approximately 2300 hours, Officer Fithian was on marked patrol, with in the city of Fort Lauderdale While traveling north along the 1400 block of SE 10th Ave (one way street), Officer Fithian noticed a pair of headlights traveling south along the same street  
Officer Fithian then stopped, reversed his vehicle and pulled to the side of the road to avoid an accident As the vehicle passed Officer Fithian, Officer Fithian

**Probable Cause Affidavit**

Before me this date personally appeared FITHIAN, JASON P (1823) who being first duly sworn deposes and says that on 11 day of May, (year) 2017 at 1400 SE 10TH AV, FORT LAUDERDALE, FL 33316 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

noticed a white male driving, later identified as Stewart Roberts, who was holding the steering wheel at ten and two and failed to notice Officer Fithian presence by looking straight ahead Officer Fithian witnessed Roberts continue to travel in the wrong direction to SE 15th Street where Roberts turned east, crossing over Cordova Road where a traffic stop was conducted

Upon contact with Roberts from the passenger side of his vehicle, Officer Fithian noticed a strong odor of an alcoholic beverage emitting from the vehicle and Roberts had visible blood shot eyes Upon asking for Roberts license and registration, Roberts first handed Officer Fithian a credit card and was unable to located a registration to the vehicle Upon retrieving his license from his wallet, Roberts apologized immediately for being stopped As Roberts spoke, Officer Fithian noticed Roberts was lethargic in his speech and seemed confused Roberts stated he was going home to Coconut Creek and upon Officer Fithian informing Roberts that he was heading east currently, Roberts stated he was sorry

Based upon the possible indicators of impairment, Officer Fithian requested Roberts to exit the vehicle As Roberts exited the vehicle, Roberts used the door to support his weight exiting the vehicle and then leaned against the vehicle in an attempt to gain his balance At Officer Fithian's request, Roberts was asked to walk to the front of Officer Fithian's patrol vehicle and in doing so, Roberts appeared to off balance and immediately leaned against the front of Officer Fithian's patrol vehicle, keeping his balance

Officer Fithian requested Robert to perform field exercises to determine if his normal faculties were impaired due to an alcoholic beverage Roberts agreed to conduct the exercises, stating he only had, "three drinks." the exercises were performed on the side of a lighted, dry, and level roadway. Roberts stated he wasn't under a

## Probable Cause Affidavit

Before me this date personally appeared FITHIAN JASON P (1823) who being first duly sworn deposes and says that on 11 day of May, (year) 2017 at 1400 SE 10TH AV, FORT LAUDERDALE, FL 33316 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

doctors care for any ailments and only [REDACTED]

Roberts also stated that he had a college education and understood the English language Each exercises was explained and demonstrated prior to Roberts attempting them

The first was the eye nystagmus, during this Roberts failed to follow simple directions of keeping his head still and swayed from side to side. Roberts also leaned against the front of Officer Fithian's patrol vehicle after being told to step away from the vehicle

The second was the walk and turn During this, Roberts was unable to maintain the starting position of left foot in front of right foot Roberts also failed to maintain his balance by raising his arms and stepping off of the solid white should line of the roadway During the exercises, Roberts failed to touch his front heel to his back toe, walked off the line numerous times and then leaned on the front of Officer Fithian's patrol vehicle again

The third was the one leg stand where Roberts decided to left his left leg. Roberts lifted his leg to a bent knee height and dropped his foot on counts four, two and four. Roberts failed to maintain his balance, raising his arms to assist in not falling.

The fourth was the finger to nose During this exercises, Roberts was unable to complete due to falling backwards onto Officer Fithian's hood each time he tilted his head back and closed his eyes

At approximately 2318 hours, Officer Fithian placed Roberts under arrest for DUI based upon the driving actions, poor performance in field exercises and the obvious signs of impairment. At approximately 2320 hours, Roberts was read Implied Consent which he stated he understood Roberts then stated he did not wish to submit to a
