The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/17/2019, at approximately 0221 hours, Deputy E. Delgado ABN 248715 conducted a traffic stop at South Vlg Dr / Dale Mabry Hw N on a silver Ford bearing FL tag IZHT42 (VIN:1ZVFT80N165141082) for operating the vehicle without headlights on after sunset. Deputy Delgado observed the defendant operating the vehicle, to be the sole occupant, and detected signs of impairment. Affiant responded to the scene, observed the defendant's eyes were bloodshot and glassy, her speech was slow and slurred, and she was unsteady on her feet. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a lawful urine sample to determine the presence of chemical and/or controlled substances. Deputy P. Blunt ABN 140618 collected the urine sample, Affiant took possession of the sample, impounded it into the Evidence Control Section, and requested the sample be sent to the FDLE Labs for further testing. The defendant was identified via FL DL. The defendant was given a Uniform Traffic Citations ABU9TJE which reflects the DUI charge, and A81QO0E for Operating A Vehicle Without Headlights After Sunset.
