The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 06/17/2021, I was working in an undercover capacity and conducting a prostitution investigation at the White Lotus Massage Spa, located at 8544 Dale Mabry Highway North Tampa, FL 33614. I entered the establishment and was asked how long of a massage I would like, in which I stated thirty minutes and provided \$60.00 in US currency to the staff. The defendant then began to massage my back for approximately 15 minutes, until she asked me to flip over. The defendant then motioned and asked if I wanted masturbation, oral sex or sexual intercourse, at which time I asked for the prices. The defendant then negotiated for sexual intercourse for \$160.00 in US currency, in which I provided to her. I then gave the predetermined arrest signal and the defendant was arrested. According to the Florida Department of Health website, the defendant is not a licensed massage therapist. The defendant was identified via her New Jersey license.
