The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a 2018 red Toyota four door bearing a Florida license plate of CKJH03. She was traveling north on Howard Ave and stopped for the red light at W Kennedy Blvd but she was stopped over the line of prolongation and actually stopped on top of the crosswalk, nearly into traffic traveling east on Kennedy. The defendant then traveled north on Howard Ave, a posted 40 MPH zone, and was paced traveling over 55 MPH (paced with my calibrated and certified speedometer). The defendant was also weaving back and forth multiple times, actually crossing over the lane divider. A traffic stop was made and it took the defendant two blocks to stop. It should be noted there were several areas she could have stopped. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .156 and .158.

The defendant was identified by her FL DL.
