traveling north on SR-91, Florida's Turnpike, around mile post 93 in Palm Beach County, Florida. I observed a blue Honda bearing FL Tag KDXF27 traveling a slow rate of speed within the right outside lane at approximately 20mph. Approximately two (2) other vehicles were behind the vehicle and needed to brake hard in order to avoid colliding into the vehicle. I made a traffic stop on the vehicle due to the driving behavior and in order to check the welfare of the subject.

The driver, identified as Surinder Aggarwal via his Washington State DL, took an excessive amount of time to pull over even when going a slow speed. Mr. Aggarwal continued to driver slowly within the exit ramp and would not pull the vehicle over. After approximately 20 seconds at a slow speed, Mr. Aggarwal pulled over and stopped within the exit ramp, blocking traffic. I walked up to the driver side widow and observed Mr. Aggarwal's eyes were glassy/wattery and red. Mr. Aggarwal's pupils were dilated and would not react to my flashlight. When Mr. Aggarwal rolled the window down, I immediately smelled the odor of an alcoholic beverage emitting from within the vehicle. I asked Mr. Aggarwal what as wrong as he stopped within the entire lane. Mr. Aggarwal looked at me confused. I immediately took Mr. Aggarwal's keys from him.

I asked Mr. Aggarwal if he had anything to drink, which he didnt respond. I asked Mr. Aggarwal where he was coming from, which he stated Coconut Creek. I asked Mr. Aggarwal for his DL which he provided to me. After running Mr. Aggarwal via NLETS with a valid response, I asked Mr. Aggarwal to step out of the vehicle. Mr. Aggarwal's speech at the time was thick and slurred with a foreign accent. As he spoke I smelled the odor of an alcoholic beverage emitting from his breath. As Mr. Aggarwal stepped out of the vehicle, he appeared uneasy on his feet. I asked Mr. Aggarwal if he was willing to participate in Standard Field Sobriety Tasks (SFST's) which he agreed.

Mr. Aggarwal performed poorly on all SFST's (See dash-cam and full Incident Report). Due to the totality of the circumstance regarding Mr. Aggarwal's driving behavior, personal interaction, and SFST performance, I concluded that Mr. Aggarwal's normal faculties were impaired at the time he operated his motor

vehicle. Mr. Aggarwal was arrested for DUI at 2348.

I confirmed that he did not regurgitate or ingest anything. I asked Mr. Aggarwal to provide a sample of his breath, which he agreed after being read implied consent. Mr. Aggarwal provided the following samples: 0.12/0.11. Mr. Aggarwal was transported to the Palm Beach County Jail for booking.

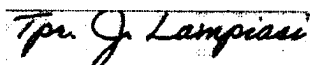

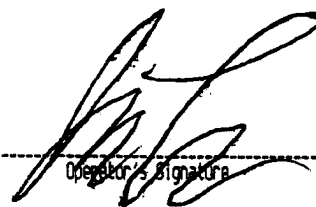
