The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was observed by the witness backing in the parking lot of the Hampton Inn and striking a pole. The vehicle continued forward and backward in the same location between the two curbs of the parking lot. The witness made contact with the defendant and found her to appear to be intoxicated. I responded to the scene and observed a maroon Lexus 4D with fresh damage to the left rear bumper consistent with hitting a concrete pole. I made contact with the defendant in the backseat of her vehicle. The defendant had slow slurred speech, bloodshot eyes, and the odor of an alcoholic beverage emanating from her breath. She was very unsteady on her feet. She stated she was not injured and did not need medical attention. I advised the defendant that I was finished with my crash investigation and beginning a DUI investigation and read her Miranda via SAO card. The defendant agreed to speak with me. The defendant admitted to drinking 2 "gin and orange juice" drinks. I asked if she would participate in SFST's and she agreed. I observed she was extremely unstable on her feet and for her safety finished the exercises after HGN. The defendant was arrested for DUI-property damage. The defendant provided breath samples of .219/.228. The defendant was ID'ed via FL DL.
