

On Friday, August 6, 2021, at approximately 0800 hrs. I responded to 22875 Ironwedge Dr located in unincorporated Boca Raton, FL in reference to a delayed domestic dispute. Upon arrival, I met with the complainant/victim identified as Kenzie Ruback. Kenzie state that that on today's date at around 1:00 AM, his soon-to-be ex-wife Sylvia Ruback showed up at his on his property and entered the residence. Kenzie stated that Sylvia claimed that she still owns "this" home and will ruin whatever is inside. Kenzie also claims that she allegedly stole his friend's property. Kenzie said that he has a valid order of no contact. A records check was conducted through FCIC/NCIC revealed a valid Order of no Contact Domestic related filed on April 18, 2021, as Kenzie Ruback the petitioner, and Sylvia Ruback the responded reference court case # 2021009325- 21CF3252MB. The order of no contact is effective until modified by the courts. Kenzie completed a sworn statement. Based on Kenzie Ruback's statement it appears the Sylvia Ruback violated the order of no contact by direct communication and coming within 500 ft. from the petitioner Kenzie Ruback. Sylvia Ruback violated a condition of pretrial release when the original arrest for domestic violence, F.S.S 741.29. Charges will be filed with the State Attorney's office for violation of no-contact order domestic-related against the defendant Sylvia Ruback. This probable cause affidavit will be forwarded to the state attorney's office for a warrant request.
