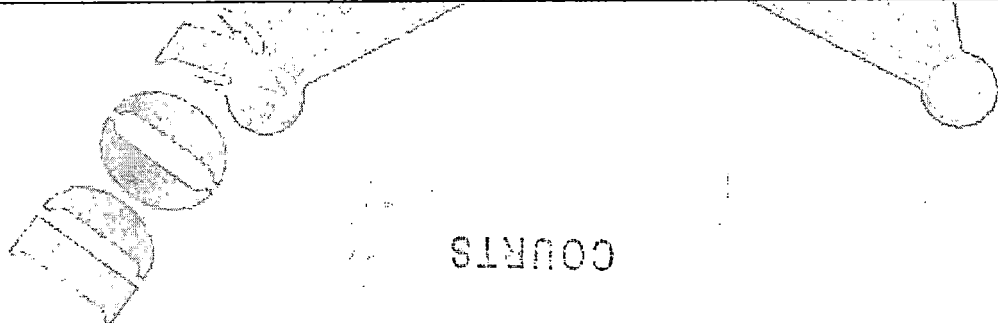

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On February 05, 2021 at approximately 2200 hours located at 18002 Birdwater Dr. Tampa FL 33647 the defendant and victim were involved in a verbal argument that turned physical when the defendant slapped the victim's left cheek with an open hand. The defendant then grabbed the victim by her throat and pushed her back. The victim then grabbed the defendant's throat in return and pushed him. Neither party was strangled (they did not loose the ability to breathe). The defendant and victim are known to each other as husband and wife. The victim identified the defendant as the person who committed the offense. The defendant struck the victim intentionally and against her will. There were children in the residence who witnessed the incident and confirmed the defendant as the primary aggressor.
