The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/22/2020, at approximately 0143 hours, I responded to Apollo Beach Bl. and Commerce Center Bl. Apollo Beach, FL. 33572. I assisted Deputy Gianni (ABN:255450) with a traffic stop. Deputy Gianni conducted the traffic stop due the vehicle (PXJN31/VIN:1FMDU32P1TZA12994) travelling off of the roadway. Deputy Gianni observed indicators of impairment from the defendant, who was in the driver's seat and the only person in the vehicle. When I made contact with the defendant, I observed him to have watery/glassy eyes, slurred speech, odor of an alcoholic beverage emitting from his breath, slow motor movements, and droopy eye lids. The defendant admitted to consuming one beer at Ricky's Bar and Grill. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant elected to provide lawful samples of his breath after a twenty minute observation. The breath results were recorded at .226 and .236. The defendant was identified via Florida driver's license.
