On 02/10/2021 at approximately 1214 hours, I was dispatched in reference to a Battery in progress at Burger King located at 1103 Royal Palm Beach Blvd in the Village of Royal Palm Beach, FL. Upon arrival I met with the complainant/victim B/F manager Milord, Janeyci who advised me the following, Milord said a customer pulled into the drive through later identified as W/F Sykes, Tami L and order several items including an orange Iced drink which was not yet available. Milord said she told Sykes that the drink was not available and Sykes drove up to the front drive through window with an attitude while being rude. Milord said Sykes was grabbing her order with force out of an employee hand and some of her food fell inside her vehicle (chicken nuggets and some fries).

Milord said Sykes then exited her vehicle entered the restaurant and throw her whole order of food in a bag at her striking her in the face. Milord said she then picked up Sykes food and throw it back at her. Milord said that's when Sykes reached out and grabbed her by her shirts collar bone area and pulled her onto the counter almost pulling her to the other side. Milord said that's when she was able to push Sykes off her while being punched in the face. Milord said she then defended herself by punching Milord back pushing the cash register where we then showed up on scene. It should be noted Milord shirt was in disarray and had a minor laceration with nails missing from her arm. Digital photos were taken of the scene with both Milord and Sykes injuries which were place to District 9 evidence.

I then spoke with Sykes who said she came into burger to order some food and was met with attitude by the employees and staff when asked for a frozen drink. Sykes said when she pulled into the front drive through window the staff throw food at her so she entered the Burger King. Sykes said while confronting the manager Milord, Milord about the food more food was thrown at her and while they were yelling profanities at her. D/S Franqui ID#8402 spoke with several independent witness one being at the counter when the incident to place known as W/F Edwards, Susan who said Sykes came into the restaurant extremely upset yelling at the staff. Edwards said she told Sykes to calm down several times and didn't listen throwing food at the employee in the face. Edwards said she told Sykes to leave but she continued to fight.

D/S Franqui then spoke with another independent witness known as W/F Richards, Shannon who was parked outside of the restaurant and saw the incident take place, Richards said while she was waiting on a friend she noticed Sykes park her car in the side of the drove throw and entered the restaurant Burger King extremely upset and mad, Richards said she then saw Sykes throw a bag of food at her face and started yelling. Richards said that's when the manager pushed Sykes away when they started fighting so she called 911. It should also be noted all witness stated that Sykes was the primary aggressor in this incident. D/S Franqui ID#8402 and I then obtained all sworn written statements from Milord, Edwards, Sykes, and Richards. Sykes was then placed into custody per department policy behind the back to the rear double locked and checked for tightness. Sykes was then transported to Palm Beach County Jail without incident.

Based on the above incident, I believe probable cause exist to charge the defendant Sykes with Simple Battery per F.S.S. 784.03(1) (A) (1)
