The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On the above listed date and time, the defendant and victim became engaged in a verbal altercation while at the Doll House strip club within Hillsborough County. The defendant and victim left the premises to return to their residence. The victim alleged the defendant kicked him prior to entering their vehicle. Once within their vehicle the defendant allegedly struck the victims left side of his face. The defendant and victim returned to their residence where the altercation continued. The defendant began throwing items toward the victim, and throughout the house. The victim restrained the defendant by grabbing her arms in an attempt to deescalate the altercation. I observed the victim to have a contusion on his left cheek and to the back of his head. The defendant sustained an abrasion to the back of her left ear. Based on the totality of the circumstances I determined the primary aggressor to be the defendant.

The defendant and victim reside together and have been married for approximately nine months. The defendant was identified via her FL DL card.
