The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was stopped for making a narrow turn and crossing the double yellow lane divider, weaving back in and out of his lane, straddling the lane divider, was slow to respond to a green light, and was blocking the crosswalk at a red traffic signal. The defendant was driving his 2020 Chevy Silverado, bearing FL tag #NRWS79. Upon making contact with the defendant, he displayed multiple indicators of impairment, including: bloodshot/glassy eyes, a distinct odor of an alcoholic beverage on his breath, sluggish reflexes, and mumbled speech. The defendant refused to perform the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .097/.093.

The defendant identified himself via his USA passport.
