The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 01/16/2021 at approximately 0211 hours, the defendant was operating a white 2018 Chevrolet Suburban with Florida tag LBDY56 in the parking lot at 1812 N 19th St. The defendant made a wide turn in the parking lot and struck the front end of a blue 2007 Toyota SUV with Florida tag Y916BU causing approximately \$500 in damages. This incident was witnessed by security (eyewitness) who confirmed that the defendant was in the front drivers seat of the vehicle and in physical control of the vehicle during the traffic accident.

Upon Ofc. T. Sikora coming in contact with the defendant in the drivers seat, he observed indicators of impairment and requested a DUI investigation. I responded to the scene and made contact with the defendant. I advised the defendant of her Miranda Rights and she elected to provide a statement advising she was drinking at a bar in Ybor City, got into the vehicle and hit another vehicle. During my conversation with the defendant, I observed that she could not stand without leaning against the vehicle, was slurring her speech, was not able to provide answers to basic questions without prompting and had bloodshot/glassy eyes. The defendant displayed multiple indicators of impairment and was arrested for DUI.

The defendant submitted to a breath test which produced a BAC of 0.150/0.156. She was positively identified via DHSMV photo.
