The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was involved in a vehicle crash at the intersection of E Davis Blvd / Biscayne Ave. The defendant fled the scene of the crash and was followed by the other involved witnesses. The witnesses called 911 and stopped following the complainant at the intersection of W Swann Ave / S Willow Ave. Approximately 10 minutes later the defendant came to where the witnesses had stopped and made contact with them. Both witnesses advised they observed the defendant driving her vehicle and stated she was the same subject driving when the crash occurred. While speaking with the defendant, I observed she had red blood shot watery eyes, slurred speech, and a strong odor of alcohol coming from her person. Upon conclusion of the crash investigation, the defendant was read miranda warning during which she invoked her right for an attorney. The defendant refused to preform field sobriety exercises and was placed under arrest. The defendant later refused to submit to a breathe alcohol test after being read implied consent. The defendant was positively identified via FL DL.
