P R O B A B L E	<p>On November 2, 2020, West Palm Beach Police Department (WPBPD) officers made contact in front of the WPBPD with Sean Hidden in reference to a court ordered custody arrangement. The order titled "ORDER ON FATHER'S AMENDED MOTION FOR CIVIL CONTEMPT OF (1) ORDER ON FATHER'S MOTION FOR TEMPORARY RELIEF, AND (2) ORDER ON Father's Motion for Enforcement and Civil Contempt of Order on Father's Motion for Temporary Relief, Motion for Makeup Timesharing, and for Attorney's Fees (In Regard to Enforcement of Timesharing ONLY), AND (3) FATHER'S MOTION FOR MAKEUP TIMESHARING, AND FOR ATTORNEY'S FEES. The order was signed by Honorable Judge Scott Suskauer on October 23, 2020 (Case No: 502019DR005738XXXXN).</p>							
	<p>The order stated that the mother, Tara Tillett (DEFENDANT), shall be present with the children, 2-year old, Courage Hidden and 2-year old Sean Hidden, for the timesharing exchange to the father on Monday, November 2, 2020, at 10:00am, at the West Palm Beach Police Department. WPBPD Officer J. Hardiman was present with the children's father, Sean Hidden, awaiting the DEFENDANT's arrival. The DEFENDENT did not respond with the children. Your Affiant responded to 601 Clematis St., WPB, at approximately 1030 hours and made contact with all parties. Sean Hidden stated that he has not seen his children since March 2020 because the DEFENDANT refused to allow him shared time. Sean Hidden stated that he was in fear that the DEFENDANT would flee the country and go to the country of Belize with the children. The order stated that if the mother shall be taken into custody and confined in the Palm Beach County Jail if not in compliance with the Court Order. It is documented in the court order, "by the mother's own testimony she indicated there is nothing prohibiting her from complying with the timesharing order. The mother testified that she chooses not to comply because she does not agree with it."</p>



On November 3, 2020, the Honorable Judge Suskauer issued an Ex Parte Motion for Child Pick Up order and order suspending mothers time sharing. Your affiant made multiple attempts to contact the DEFENDANT with negative results.

Based on the above stated facts, the DEFENDANT without lawful authority, knowingly and willingly refused to comply with a Judicial order to share custody of her children with their biological father and has such interfered with his lawful custody. Your Affiant finds probable cause exists to arrest the DEFENDANT and charge her in violation of F.S.S 787.03 Interference with Custody.
