

P R O B A B L E C A U S E S T A T E M E N T	<p>This Officer arrived on scene and made contact with Paula Sanzaro Pietruszka (VI-3) who stated her vehicle, a BMW sedan (SEASDAY/FL) was parked unoccupied, when it was struck by a black GMC Yukon (NDBB70/FL), driven by a blonde female, later identified via Florida Driver License photo, Tatiana Miftakhova (OF). This Officer was then approached by Miftakhova who volunteered that she was driving the Yukon. This Officer observed Miftakhova to have red watery glassy eyes, slurred speech, flushed red face and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. Miftakhova claimed to have bad vision which contributed to the collision.</p>								
	<p>This Officer then spoke with Pietruszka who then said "I'm not sure if she was driving or he was driving". Miftakhova then immediately said she was driving. While this Officer was completing the initial crash report information, Ofc Hennessy 409 advised Miftakhova of her Miranda Warnings, to which she acknowledged and did not have any questions. This Officer then spoke with Pietruszka again, who was now agitated when this Officer said the Yukon did not have insurance information available. Pietruszka then said the passenger, Scott Holey (IO), identified via Florida Driver License photo, was the driver. Pietruszka further said her friend, said Holey was the driver, the unidentified friend then said he did not know who was driving. Pietruska then kept saying Holey was the driver. Miftakhova was standing on the other side of Pietruska's vehicle saying she was in fact the driver.</p>								
	<p>This Officer then reminded Miftakhova that she was advised of Miranda Warnings, to which she said she remembered being advised. Miftakhova then raised her right hand and swore</p>

	<p>to being the driver of the vehicle. Miftakhova denied consuming alcohol at the establishment. Pietruska then approached this Officer and again said Holey was driving and the two begged her not to say anything. This Officer explained to Pietruska that she has now said three different statements to this Officer. It should be noted, Pietruska appeared heavily intoxicated by alcohol. Pietruska claimed to "feel bad" for Miftakhova, which is why she lied to Officers. Pietruska then apologized and claimed she "fucked up". Ofc Hennessy then explained to Miftakhova the parking lot has cameras, to which she still claimed to be the driver even with this knowledge, which was also suggested by Pietruska. This Officer then dismissed Pietruska while the investigation continued, due to her inconsistent information.</p> <p>This Officer then advised Miftakhova the investigation was no longer a crash investigation and now a driving under the influence investigation. Miftakhova claimed to have an eye condition with her left eye. Miftakhova then requested an attorney, to which this Officer advised her of Taylor Warnings. This Officer then explained Taylor Warnings to Miftakhova piece by piece and multiple times. Miftakhova eventually agreed to participate in Standardized Field Sobriety Exercises.</p> <p>The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3. This Officer observed lack of smooth pursuit in both eyes. This Officer also observed sustained involuntary jerking in both eyes at maximum deviation and the onset of Nystagmus prior to 45 degrees in both eyes. Miftakhova also had Vertical Gaze Nystagmus in both eyes.</p> <p>The next exercise to be conducted, was the Walk and Turn. Miftakhova claimed to have a medical condition which would affect the exercise, thus the exercise was not conducted.</p> <p>The next exercise conducted was the Finger to Nose. Miftakhova started the exercise prior to being told to do so. The following observations were made: the first three commands, Miftakhova searched for her nose and missed the tip of her nose and had to be told to lower her hand. The fourth command, Miftakhova searched for the tip of her nose and again had to be told to lower her hand. The fifth command, Miftakhova raised the wrong hand then corrected herself, again searched for the tip of her nose and had to be told to lower her hand. The sixth and final command, Miftakhova touched under the tip of her nose and had to be told to lower her hand.</p> <p>The next exercise conducted was the Hand Coordination. During Task 1, Miftakhova did not count aloud and only made three step-like motions rather than four. Miftakhova then did not conduct Task 4, of bringing her palms to her lap.</p> <p>The final exercise conducted was the Modified Rhomberg Balance. Miftakhova estimated the passage of 30 seconds in approximately 33 seconds.</p>



At the PBSO BAT, this Officer requested Miftakhova to provide a breath sample for the purpose of determining its alcohol content, to which she refused. This Officer read and explained Florida Implied Consent to Miftakhova, to which she eventually acknowledged and again refused for a final time at 0435 hours.</p> <p>Based on the results of the investigation, this Officer has probable cause to prove Tatiana Miftakhova operated a motor vehicle, in the state of Florida, while under the influence of alcohol to the extent her normal faculties were impaired, in violation of FSS 316.193(1) (A). Miftakhova's actions, while impaired, caused damage to two vehicles which did not belong to her, in violation of FSS 316.193(3) (C) (1).</p>

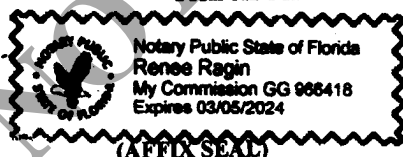
