The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
On 12/18/2020, at approxamltey 0131 hours, near the intersection of Bloomingdale Avenue and Old Twig Lane, Brandon, Florida 33511 Deputy D. Canon ABN: 260302 observed the defendant operating a black 2017 Ford Direct bearing Florida tag PJLJ79 with an assigned VIN of 2FMPK3K99HBB86973 failing to move over for an emergency vehicle (on a traffic stop) and affecting the normal flow of traffic. Upon Deputy Canon's contact with the defendant/driver, he observed multiple indicators of impairment. Upon the affiant's contact with the defendant, I observed her to have watery/glassy eyes, slurred speech, she was unsteady on his feet, she had a red in color face, and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant refused to participate in the field sobriety exercise. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she provided two lawful breath samples of .253 and .241. I further identified the defendant via her DAVID photograph.
