The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a 2019 white Audi SUV bearing a Florida license plate of 884TYZ. She was traveling west on W. Kennedy Blvd near S Lois Ave and was paced traveling 65 MPH in a posted 40 MPH zone. In addition, the defendant was weaving back and forth, touching the lane dividers multiple times and nearly struck a curb. The defendant also came to a stop at S. Westshore Blvd for a red light but appeared to have an altered perception of distance as she stopped over the line of prolongation (stop bar). She came to a quick stop when she realized she was going over the stop bar and then once she was stopped she reversed her vehicle to get behind the stop bar. A traffic stop was conducted and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol (three drinks, a mix of margaritas and "hard seltzers"). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. The defendant was identified by her FL DL.
