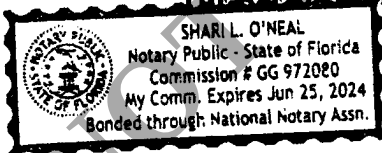

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Wednesday March 23, 2022 I responded to the intersection of Australian Avenue and S. Congress Avenue Palm Beach County Florida regarding a female motorist passed out in her vehicle. The call was received by PBSO Communications from a passing motorist concerned for her welfare. Upon arrival I observed the defendant seated in the driver seat. Palm Beach County Fire Rescue was on scene. They informed me the defendant refused to speak to them. I approached the driver side of the defendant's vehicle. She was the sole occupant. The passenger seat had a cardboard box containing bottled beer. There were several beers missing from the box. I said hello to the defendant through her partially open window.

OBSERVATION OF DRIVER:

I observed the defendant to have red and bloodshot eyes. I attempted to engage in dialog with the defendant. She kept saying no and nope and I'm not doing this. I asked the defendant to exit her vehicle and she picked up her phone to begin calling someone. I attempted to use the ignition key that was removed by a back up Deputy. The key turned the lock but the lock mechanism was not functioning on the door. I reached into the open window and opened the door to the driver seat utilizing the interior handle. I then told the defendant to exit the car. She elected to take a draw from her vape. I placed my hand around her left wrist and she screamed at me that she was getting out and exited the vehicle. I observed the defendant to be unsteady on her feet. As we walked from her vehicle to mine, I kept the tips of my fingers in contact with her back to guide her in the correct direction. As soon as we were near the front of my car the defendant immediately leaned on and held onto the front push bumper to steady herself. The defendant said she lived nearby and asked if her mom could just pick her up and take the car. I observed the defendant's clothing was properly worn. The defendant's eyes were red, glassy, and bloodshot.

DRIVER'S STATEMENTS:

The defendant said she does not do drugs and said she had nothing to drink.

ODORS:

I immediately detected the odor of an unknown alcoholic beverage emanating from the defendant's breath that intensified when she spoke.

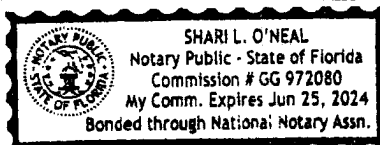

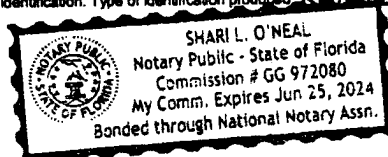
