The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a silver Nissan 4D bearing FL tag JZLC47. The defendant was involved in a traffic crash causing approximately \$13,000 in damages. I arrived on scene shortly after the crash and observed the defendant standing near, then going into the vehicle. There were no other passengers in her vehicle. The driver of the other vehicle (witness) positively identified the defendant as the driver at the time of the crash. I made contact with her and observed her to have bloodshot and glassy eyes and her pupils appeared dilated. She advised she was uninjured from the crash and I observed a red diagonal mark on her left shoulder indicative of a seat belt burn. She provided her registration showing her as the owner of the vehicle. As I spoke with her, her speech sounded slurred at times and she exhibited mood swings from regular conversation to crying and emotional. I detected the odor of an alcoholic beverage emanating from her breath. I observed she was unsteady on her feet and stagger as she walked near the crash scene. I advised her that I was now conducting a DUI investigation and read her Miranda via SAO card. She stated she understood and agreed to speak with me. She admitted to driving at the crash and previously drinking. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant provided breath samples of .202/ .223/ .222.

The defendant was ID'ed via FL DL.
