The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 03/24/2021 at 0234 hours I conducted a traffic stop on a 2000 beige Lexus sedan, FL tag QQZI72 after I paced the vehicle speeding, 50 MPH plus in a posted 35 MPH zone, W/B on Cleveland St W.
