(Specifically include facts constituting cause for arrest.)</p> <p>On 1/3/2021, at approximately 0358 hours, I was dispatched to Brickyard Bar, located at 7050 Palmetto Park Rd, unincorporated Boca Raton, Palm Beach County, Florida, in reference to a subject at the bar with a firearm.</p> <p>On arrival, I made contact with the manager, Osie Joseph, who stated that a patron, white male later identified as Tenor Jason Guilbert, was being detained at the location because he was consuming alcohol at the bar with a weapon. Joseph stated that he received a report that Guilbert told others that he was a federal agent and raised his shirt to reveal a Glock 26, 9x19mm that was holstered in his waistband. Joseph stated that he alerted the private security on site and they responded to the area.</p> <p>I then made contact with a patron, Matthew Simmons, who provided me with a sworn written statement, took a verbal oath to same, and stated that he was at the bar when Tenor Guilbert arrived. Guilbert began to talk to a female and Simmons at the bar. During the conversation Simmons stated that Guilbert told him that he was a federal agent under cover, then he raised his shirt to reveal a Glock 26, 9x19mm, SN#ADAL560 while Guilbert was drinking a Corona beer. The firearm was holstered and tucked inside Guilbert's waistband on his right hip. Simmons stated that there was no argument or disturbance, and that Guilbert did not make any threats during the conversation. Simmons stated that he alerted employees, then the private security for the location arrived, detained Guilbert and disarmed him.</p> <p>On arrival the secured firearm was turned over to me by the private security officer.</p> <p>Guilbert was placed under arrest for carrying a concealed weapon with CCW in a forbidden place. During the search incident to arrest a small clear plastic bag containing white powder was found in the front pocket of Guilbert's wallet, behind his CCW license. The white powder was field tested with the Marquis and Cobalt kits, which resulted in a positive reaction for Cocaine. Guilbert also admitted that the white powder was 1 gram of Cocaine. Guilbert was handcuffed to the rear, checked for fit, and double locked. Guilbert was placed in the back of my marked patrol vehicle.</p> <p>Based upon my investigation, probable cause exist to charge Tenor Jason Guilbert with one count of possession of a schedule II substance Cocaine in violation of F.S.S. 893.13(6)(a), and one count of carrying a concealed weapon with a CCW in a forbidden place (bar) in violation of F.S.S. 790.06(12)(a).</p> <p>I completed a Log Entry for this case.
