## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 12-27-20, I responded to 400 N Swinton Ave to the scene of a traffic crash to conduct a DUI investigation. Upon arrival, I made contact with a Hispanic female who advised she was the driver and the sole occupant of the white Honda Civic and later identified as Teresa Alexander Orozco by her Florida driver license. While on scene I observed the white Honda Civic stationary facing westbound in a parking lot with front-end damages and driver side airbag deployment.

## OBSERVATION OF DRIVER:

The driver Alexander Orozco was standing outside of her vehicle and had the smell of an unknown alcoholic beverage emanating from her person. Alexander Orozco appeared impaired, had glassy eyes, slow dexterity, slow comprehension, and was unstable while standing in an area for roadside tasks.

## DRIVER'S STATEMENTS:

I read Miranda Warning to Alexander Orozco verbatim from my department issued Miranda Warning card in which she stated she understood. Post Miranda Alexander Orozco advised she was the sole occupant and the driver of the 2013 white Honda Civic bearing FL tag (622RJH) that was involved in a traffic crash. Alexander Orozco also advised she had a couple drinks at a local establishment (Tin Roof, located in Delray Beach with some friends. Alexander Orozco also advised she was unable to recall the events leading up to the traffic crash.

## ODORS:

Strong odor of an unknown alcoholic beverage emanating from her person.

## GENERAL OBSERVATIONS

SPEECH: Slow, and mumbled.

ATTITUDE: Was originally calm, then displayed different mood swings while being handcuffed.

CLOTHING: Yellow shirt, blue jeans, and black boots.

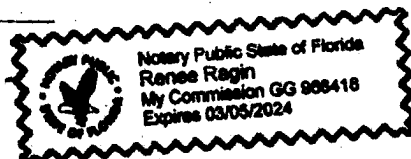
