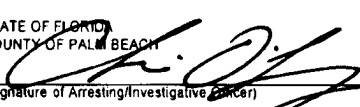

I was patrolling the Intracoastal Waterway in the area of 900 E Blue Heron Boulevard, West Palm Beach, Palm Beach County, Florida 33404, when I observed a white male, later identified verbally as being named Douglas Maxwell, and a white female, later identified verbally as being named Thalva Kombor, traveling northbound in a 10-foot inflatable vessel. As I was traveling northbound behind the vessel, I observed a physical altercation occurring between Kombor and Maxwell. I observed Kombor strike Maxwell multiple times as he was operating the vessel. I immediately conducted a traffic stop on the vessel and had Maxwell relocate to the back of my Palm Beach County Sheriff's Office (PBSO) patrol vessel. While speaking with Maxwell, he stated that he and Kombor were arguing and that they were going to continue traveling home for the night. Maxwell requested to ensure that Kombor made it home safely so that they could be separated for a short period of time. I requested Maxwell complete a PBSO Sworn Statement but Maxwell refused. At this time, I began speaking with Kombor who stated that Maxwell was acting jealous as they were at the Peanut Island sandbar and that they were arguing regarding the jealousy. Kombor stated that she never struck Maxwell during the altercation. Kombor stated that she and Maxwell were dating and that they recently moved and are living in the same residence. Thalva Kombor did actually and intentionally touch or strike Douglas Maxwell against the will of Douglas Maxwell and Douglas Maxwell was a family or household member of Thalva Kombor, contrary to Florida Statute 784.03(1), 741.28 and 741.283.
