at approximately 6:45 AM, at 3100 BLOCK OF GULF TO BAY BLVD, in Pinellas County did:

THE DEF WAS OBSERVED IN ACTUAL PHYSICAL CONTROL OF HIS VEHICLE WHEN HE WAS OBSERVED BY SERGEANT CAMERON TO BE TRAVELING WESTBOUND AND UNABLE TO MAINTAIN A LANE. SERGEANT CAMERON OBSERVED THE DEF CROSS THE LANE DIVIDING LINE THREE TIMES IN LESS THAN HALF OF A MILE. HE ALSO OBSERVED THE DEF ACCELERATE AND DECELERATE BETWEEN SEVENTY AND FIFTY MILES PER HOUR MULTIPLE TIMES. SERGEANT CAMERON INITIATED A TRAFFIC STOP AND OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY GLASSY EYES, SLURRED SPEECH, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AND PERSON. IT SHOULD BE NOTED THE DEF ALSO HAD A YELLOW NEON BRACELET THAT STATED "OVER 21." THIS OFFICER ARRIVED ON SCENE AND OBSERVED THE SAME SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY/GLASSY EYES, SLURRED SPEECH, SWAYING BACK AND FORTH, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AND PERSON. THE DEF PARTICIPATED IN ALL SFST AND PERFORMED POORLY ON ALL SFST. THE DEF THEN PROVIDED A SAMPLE OF HIS BREATH SHOWING HIS BRAC TO BE 0.153 AND 0.155.

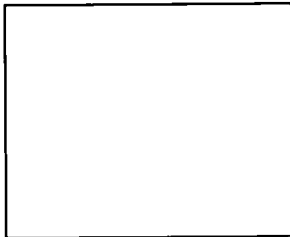
