at approximately 2:48 AM, at 6300 GULF BLVD, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT: SCREAMING ON HOTEL BALCONY KEEPING NEIGHBORS AWAKE, AS WELL AS HAVING A VERBAL ARGUMENT WITH GROUP OF SUBJECTS ON FIRST FLOOR.

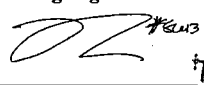

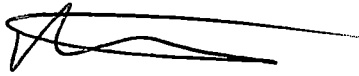
ADVISORY AND SOLVENCY HEARING

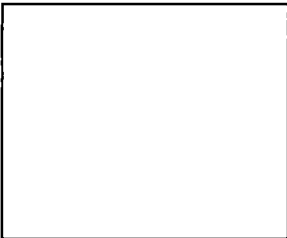
