The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed the defendant driving a black Hyundai with FL tag JMAG12 on the roadway. He was coming from behind me in the right lane at a high rate of speed. Officer Baden was in the right lane in front of me. The defendant drove right up to the rear of Officer Baden's vehicle then changed lanes in front of me and continued speeding. I visually estimated his speed to be 60 miles per hour in a 40 mile per hour zone. I confirmed his speed with the calibrated speedometer in vehicle #5050. I conducted a traffic stop and made contact with the defendant who was in the driver's seat. Upon contact with the defendant I could smell the odor of alcoholic beverages from his breath. His eyes were glassy and bloodshot. He admitted to drinking 3 beers and smoking marijuana. There were several open and empty beer cans in the cup holders and back seat of the vehicle. He performed field sobriety exercises and showed impairment. His breath alcohol content was .200 / .182. Defendant ID'd by NY DL.
