The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: Thomas Eder was driving a white Toyota Corolla bearing FL(JLDG13) that was stopped for suspicion of DUI after I observed it stopped within inches of another vehicle, make turns from the wrong lane, switch lanes at the last second, weave within its lane of travel, cross the lane markers and fail to maintain a single lane while turning. During observations Eder displayed indicators of impairment to include having red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on his breath. During SFST's he displayed additional indicators of impairment and was arrested for DUI. He was taken to CBT where he took the breath test. He provided breath samples of .181/.147/.153.
