The defendant had watery and droopy eyes, very slurred speech and a strong odor of an alcoholic beverage emitting from his breath as he spoke. Defendant was administered a series of SFST's which he displayed extreme difficulty performing. Defendant was arrested for DUI and transported to CBT where he was administered a breath test. This occurred in Hillsborough County, Florida. BrAC measured .234 / .228
