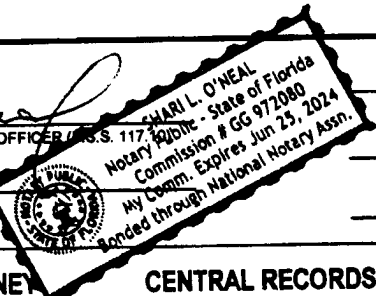

On 03/04/2022 at approximately 2235 hours, this Officer was conducting a traffic enforcement selective in the area of PGA Blvd and Minsk Gardens Blvd, PBG, FL, when a vehicle was observed traveling east bound at an increased rate of speed. Body worn camera and in car video were activated upon traffic stop. This Officer visually esintated at approximately 70 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), rear antenna (KR027120) this Officer received a steady tone and reading of 68 MPH, while the vehicle was still west of Campus Dr. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. As the vehicle passed Campus Dr, it decreased in speed to approximately 58 MPH as it passed this Officer, still in the same 45 MPH zone. This Officer entered the lane behind the vehicle, a Hyundai sedan (IDL5G/FL) and attempted a traffic stop in the right-hand turn lane of PGA Blvd before entering The Meadows, 2555 PGA Blvd, PBG, FL. The vehicle entered The Meadows and this Officer activated the audible siren as well, to which the vehicle continued forward, then made a right-hand turn and parked at Lot #152. The driver then opened the door and attempted to exit before this Officer advised not to do so. This Officer made contact with the driver and sole occupant, identified via Florida Driver License photo, Thomas Stover (OF) while he was still in actual physical control of same. Stover had mumbled and slurred speech, glassy watery eyes, low heavy eyelids and the strong obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Stover had difficulty dividing his attention, between speaking with this Officer and locating documents. Stover said he was coming from dinner at Outback and a friends house.

Based on this Officers observations Stover was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. Stover was uneasy on his feet and walked with an unsteady gait. Stover mentioned diabetes and a foot condition. Stover was instructed not to remove his shoes, to which he disregarded and removed his right sneaker. This Officer made note of Stovers conditions and applied them to the exercises. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Streamlight Stylus. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation, as well as the onset of Nystagmus prior to 45 degrees in both eyes. Stover was swaying back and forth during the exercise and had to be told to follow the stimulus properly. The next exercise conducted, was the One-Leg Stand. For the exercise, Stover was relocated to the sidewalk for a level surface to conduct the exercise. As Stover walked to the sidewalk, he stumbled into the grass. Stover raised his right foot, the injured foot, for the exercise. As Stover would raise his foot, he would lose balance and drop it before he could count. Stover also raised his arms more than six inches from his sides. After placing his foot down the second time, Stover stepped forward and said "I cant do itso...". This Officer asked Stover to attempt one more time and palced his foot down a third time, ending the exercise. The next exercise conducted, was the Rhomberg Alphabet. During the exercise, Stover awayed back and forth. Stover recited A through E then paused and continued to N then said I O M P, then Q through Z. The final exercise conducted, was the Finger to Nose. When told to begin, Stover did not tilt his head nor close his eyes. The following indicators were observed: First command of Left, Stover slowed as he brought his hand up and used the pad of his finger. First command of Right, Stover used the pad of his finger. Second command of Right, Stover used the pad of his finger. Second command of Left he touched under the tip of his nose. Third command of Left, Stover again touched under the tip of his nose. Based on this Officers observations, Stover was placed under arrest at 2251 hours. At PBSO BAT, this Officer requested Stover to provide a breath sample for the purpose of determining its alcohol content, to which he refused. This Officer read Florida Implied Consent to Stover to which he acknowledged and again refused at 2348 hours. Based on the results of the investigation and the totality of the circumstances, this Officer has probable cause to prove Thomas Stover operated a motor vehicle, in the state of Florida, while under the influence to the extent his normal faculties were impaired, in violation of FSS 316.193(1) (A).

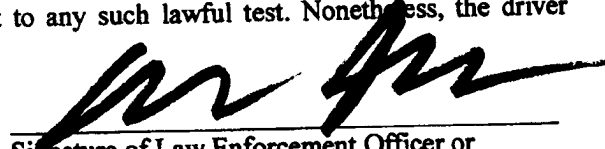

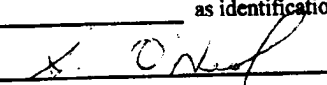
