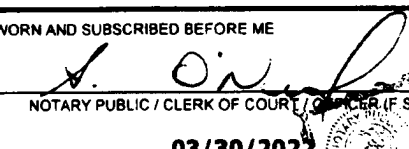

On the <u>29</u> day of <u>March</u>, <u>2022</u> at <u>23:50</u> (Specifically include facts constituting cause for arrest.) On 03/29/2022 at approximately 2350 hours, this Officer was conducting speed measurement enforcement in the area of the 12300-block of Central Blvd, PBG, FL, when a vehicle was observed traveling at an increased rate of speed north bound in the outside through lane. Body worn camera and in car video were used in the investigation. This Officer's initial visual estimation of the vehicle, was 75 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), front antenna (KC086606) this Officer received a steady tone and reading of 75 MPH. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer informed Ofc Basinger 428 of the speed and that it was the only vehicle north bound, since Ofc Basinger was positioned to more safely enter the roadway. Both Officers caught up to the vehicle, a white Porsche sedan (QWTT52/FL) at the red light for the left-hand turn lane of Central Blvd to west bound Hood Rd. Ofc Basinger initiated a traffic stop on same just west of Central Blvd, while still in Palm Beach Gardens. This Officer was present through this entire time. After Ofc Basinger made initial contact with the driver, this Officer approached the driver window and made contact with the driver. The driver was identified via Florida Driver License photo, Thomas Mohen (OF), while he was still in actual physical control of the vehicle. Mohen had glassy watery eyes, flushed red face and the odor of an unknown alcoholic beverage emanating from his breath at conversational distance. It also appeared to this Officer that Mohen had urinated in his pants. Mohen said he was coming from "La Masseria" and was on his way to East Pointe. Mohen further said he had consumed "two glasses of wine".

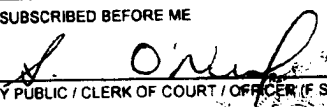

Based on this Officer's observations, Mohen was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. As Mohen walked to the rear of his vehicle, he did stumble one time. Mohen mentioned medical conditions, which this Officer took into consideration for the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3 with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Mohen also had the onset of Nystagmus prior to 45 degrees in both eyes. During the exercise, Mohen was orbitally swaying. The second exercise to be conducted, was the Walk and Turn. During instructions, Mohen informed this Officer of a medical condition which would affect the exercise, thus this Officer ended the exercise to not place Mohen at a disadvantage. All subsequent exercises were performed while Mohen was seated on Ofc Basinger's push bumper. The second exercise actually performed, was the Finger to Nose. Once told to begin, Mohen did not close his eyes until told again to do so. During the exercise, the following observations were made: first command of Left, Mohen touched under the tip of his nose, then searched and touched the tip of his nose. Mohen had to be told to lower his hand. The first command of Right, Mohen touched above the tip of his nose, searched, then touched the tip of his nose. Mohen again had to be told to lower his hand. Mohen was then reminded to lower his hand after he touches his nose. The second command of Left, Mohen touched the left side of his nose. The second and third commands of Right, Mohen touched his nose with the pad of his finger. The final command of Left, Mohen touched his nose with the pad of his finger. The third exercise conducted, was the Palm Pat. Mohen did not count aloud, until told twice to do so. Mohen also had to be told to increase in speed. Given a condition Mohen mentioned, this Officer understood Mohen could not completely rotate his hand, thus the observation of "chop pat" was not factored into this Officer's observations. The fourth exercise conducted, was the Hand Coordination. During Task 1, Mohen did not count aloud. During Task 3, Mohen did not return his left hand to his chest. The fifth and final exercise conducted, was the Rhomberg Alphabet. Mohen recited the alphabet from A through V, then skipped W and continued through Z. Based on this Officer's observations and the totality of the circumstances, Mohen was placed under arrest at 0006 hours. At PBSO BAT, this Officer requested Mohen to provide a breath sample for the purpose of determining its alcohol content, to which he refused. This Officer read Florida Implied Consent to Mohen, to which he acknowledged and again refused at 0104 hours.
