The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/26/2020 at approximately 03:49 hours, I responded to 5223 Orient Rd in reference to the report of a battery. Upon arrival, contact was made with (V1) (ID by N/FCIC) who advised he was struck in the face by the def. causing a red mark on his neck. (W1) advised she observed the def, slap (V1) in the face/upper neck area. A review of surveillance video revealed the def. intentionally struck (V1) against his will. Video shows (V1) pushing the def. after the def. grabbed his face. Contact was made with Thomas P Matthews (Def. ID by FL DL) who advised he slapped (V1) only after (V1) pushed him which is contrary to what was observed on surveillance footage. The def. was taken into custody and transported to Orient Road Jail without incident.
