

Brooks was immediately caught in the rear of the business sucking on the chemicals of one of the Computer Duster Cannisters by Deputy Sheriff M. Avila. Brooks was clearly under the influence and medics responded and cleared him of any emergency medical issues.

The total of items stolen over that time is \$31.50.

I observed the receipt of the items taken. Brooks had the two cannisters of the Computer Duster next to him at the time of apprehension.

Brooks was advised that he was under arrest for Retail Theft.
