 On 11/07/2020 at 0331 hours I conducted a traffic stop on a white 2019 Chevy Cruz sedan after I paced the vehicle at 70 MPH in a posted 40 MPH zone, westbound on Kennedy Bl W. Upon contact with the driver of the vehicle, defendant Thyme Evilsizer, I observed that she had bloodshot glassy eyes and then as I explained to her why I had stopped her I detected a very strong and distinct odor of an alcoholic beverage. When I asked the defendant how much did she have to drink tonight, she replied "not that much". The defendant then refused to perform the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0338 hours. I then transported the defendant to the HCSO/CBT Facility where she submitted to a breath test. Her BAC was .114/.113. I identified the defendant with a valid FL DL.
