The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 08/03/2020 at approximately 2102 hours, I responded to the incident location reference a battery domestic call for service. Upon arrival I made contact with the victim who advised him and the defendant were engaged in a verbal argument over the defendant having too much to drink. The verbal argument turned physical when the defendant willfully and intentionally struck the victim with her right closed fist on the right side of the victim's face. The defendant then willfully and intentionally struck the victim by kicking him on the right side of his chest against is will. The victim sustained a minor injury to the right side of his face and his right side of his chest and refused medical attention. The victim identified his girlfriend, the defendant as the person that committed the battery in person while on scene.

The defendant was located outside the residence and spontaneously stated "I didn't do anything wrong and I haven't been drinking".

The victim and defendant are boyfriend/girlfriend and have lived as a family unit for over a year and share no children in common.

The defendant was placed in custody and transported to ORJ without further incident.
