PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.
On 03/02/21 at 1858hrs, Ryan James Mason (complainant/witness) notified the Delray Beach Police Dispatch of a possible intoxicated white female driver in the parking lot of 1750 S. Federal Hwy. The vehicle description given by Mason was a white BMW Z4 (FL Tag #EITF06). Ofc. Delice #1182 DBPD arrived on scene and took possession of the BMW key fob from Mason. The white female driver was standing outside the BMW. I arrived on scene and met with Mason. I identified Mason by his FL DL. Mason provided a sworn statement which was recorded on my body worn camera. Mason stated he was traveling south in a parking aisle approaching an entrance/exit aisle connected to S. Federal Hwy. Mason observed the BMW stopped at a stop sign prior to the entrance/exit and not moving. Mason stated the entrance/exit was clear and the BMW did not move. Mason drove up to the driver door and observed the white female driver asleep behind the wheel. Mason pulled over and exited his vehicle to check on the white female driver. Mason stated the BMW's engine was running and the white female driver was sitting in the driver seat. Mason stated the white female driver was the only person inside the BMW. Mason was able to wake up the white female driver. Mason stated the white female driver stated she was not moving because she did not know how to operate the BMW. Mason stated the white female driver initially stated she had not consumed any alcoholic beverages and later stated to Mason she consumed one alcoholic beverage. Mason instructed the white female driver to shut off the engine which she did. The white female driver exited the BMW and left the vehicle key fob on the BMW's seat. While Mason was contacting the police, the white female driver re-entered the BMW and sat down in the driver and started the engine. Mason reached in the BMW and shut off the engine and took possession of the BMW's key fob. Mason identified the white female on scene as the person who was operating the BMW and he never lost sight of the white female driver during the incident. I met with the white female driver and identified her by a photograph in D.A.V.I.D. as Tiffany W. Terrazzano. Terrazzano stated she was operating the BMW and she was having issues with the parking brake. After arrest was made, I searched the BMW prior to tow and found a cold open wine bottle in a large purse. The purse was sitting on the passenger front seat and Terrazzano had direct access to the wine bottle while sitting in the driver seat. The wine bottle was 750ml Josh Cellars Chardonnay and I poured the bottle out in front on my patrol vehicle. D.A.V.I.D. records show Terrazzano has two prior DUI convictions on 12/09/2010 and 09/15/2011. The BMW's tag was expired as of 08/09/2019.

OBSERVATION OF DRIVER:

I immediately smelled a strong odor of an unknown alcoholic beverage coming from Terrazzano. Terrazzano was unsteady on her feet and was leaning against a DBPD patrol vehicle for balance. Terrazzano's eyes were red and had a glassy appearance. Terrazzano's pupils were very slow to change in size when exposed to changes in light. Terrazzano's speech was slurred while she was speaking. Terrazzano was very repetitive while speaking. Terrazzano had mood swings from being friendly and laughing to acting belligerent screaming profanity toward Mason and officer on scene. Terrazzano was not aware what time it was. Terrazzano stated the nearby intersection was "Linton & Shitville". After arrest Terrazzano became uncooperative by tensing her arms and not following my commands to walk to the front of my patrol vehicle. Terrazzano was making demands to be released and screaming at me stating "Why would you do this?"

DRIVER'S STATEMENTS:

Terrazzano stated she recently had her finger and toe nails serviced at a nail salon prior to driving. Terrazzano stated the nail salon was called "Sazzy" but Terrazzano would not state what plaza or location of this nail salon. Terrazzano stated she was on her way home when the police arrived on scene. Terrazzano did not state why she was in this parking lot. Terrazzano stated she did not have any medical conditions, take any prescription medications or consume any illegal drugs including marijuana prior to driving. Terrazzano stated she consumed one glass of wine 3 hours prior to driving. Terrazzano did not state where she consumed the glass of wine. Terrazzano stated she drove the BMW to this location. I requested Terrazzano perform roadblocks to dispel my suspicion that she was driving under the influence. Terrazzano refused to perform roadblocks and I informed Terrazzano of Taylor Warning. Terrazzano stated she did not understand Taylor Warning and I attempted to explain Taylor Warning to Terrazzano. While I was explaining Taylor Warning, Terrazzano began to speak over me and would not answer my questions. Terrazzano began to stare at Ofc. Delice. Ofc. Delice walked away to speak with another officer and Terrazzano continued to have a blank stare in the same direction. At this point Terrazzano would not speak to me or any other officer on scene and was placed under arrest.

I smelled a strong odor of an unknown alcoholic beverage coming from Terrazzano.
