The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above listed date, time, and location I observed a blue Chevy Silverado bearing MO tag #1FCE08 (Vin:1GCGK13U73F157118) traveling westbound on Bloomingdale Av. from Bloomindale Trails Bl. I observed this vehicle traveling in the inside lane and touch the dotted lane divider. I observed this vehicle weave to the left and touch the solid yellow line. I observed this vehicle pass by the speed measurement device at 54 MPH in a posted 45 MPH at Bloomingdale Av. / Watson Rd. I activated my emergency equipment to conduct a traffic stop. I made contact with the defendant and observed signs of impairment to include bloodshot watery eyes, and the odor of an alcoholic beverage emitting from his breath. Post Miranda, the defendant admitted to consuming five Samuel Adams beer at Racoons Bar and Grill. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises the defendant showed signs of impairment and was arrested for DUI. The defendant provided two lawful breath samples after a 20 minute observation period (BAC .190/.194). The defendant was identified via Missouri ID card photo.
