

On the 1 day of January, 2020 at 08:03 (Specifically include facts constituting cause for arrest.)

On Wednesday, January 1, 2020 at 8:03 a.m. I responded to 1006 10th Ct, Palm Beach Gardens, FL about a follow up. I spoke with the victim, Jennifer Fider, who gave a sworn verbal statement which was recorded by my body worn camera. This is the third time this agency has responded to this address reference harassing phone calls made to Fider.

On December 19, 2019, I first responded to Fider for harassing text messages from her ex-boyfriend Timothy Frazier. Then she explained on December 18, 2019 at 3:55 p.m. she texted Frazier stating she wanted him to stop calling, texting, and emailing her for the next two weeks. At 3:56 p.m. Frazier texted back and began an argument. However, Fider did not respond to his texts. Later Frazier texted Fider through WhatsApp, Frazier texted Fider eighty-nine times from 3:56 p.m. to 12:49 a.m. Fider explained how this has caused her substantial emotional distress and she fears for her own safety because of Frazier's actions. Fider said she felt harassed from the constant texting from Frazier which caused her phone to continually notify her of his texts. At that time, she did not want to prosecute, and she did not want me to call Frazier in fear it would worsen the situation.

On December 23, 2019, Officer Guadalupe with this agency responded to Fider who stated Frazier has continued to harass her with text messages. Officer Guadalupe left a voicemail for Frazier to contact him concerning the harassing text messages. However, Frazier did not return Officer Guadalupe's message. Again, Fider did not want to prosecute.

Since December 24, 2019, Frazier has texted her twenty-four times and has sent her three emails. Fider says she has not responded to any emails or text messages. Each text and email write about how much Frazier loves Fider and how great their relationship was. Frazier was apologetic in his writing stating she was the only one for him. There were a few texts and emails stating this was "goodbye." However, no threat of harm was


written. Fider also explained she had already blocked Frazier's phone number, but he has since gotten a new number (954) 270-2125 which he used to contact her.

Fider reiterated how all these incidents has caused her substantial emotional distress and she fears for her own safety because of Frazier's actions. Fider said she has felt harassed from the constant texting and emails from Frazier which caused her phone to continually notify her of his texts. Fider became more distressed when Frazier changed his phone number and texted her from the new number. Fider advised she wants to prosecute for the harassing text messages and emails. Fider has blocked all of Frazier's contact information and she has told his adult children to stop contacting her. I sent Fider an invitation to upload the screenshots of the text messages and emails from Frazier to evidence.com.

I left a voicemail for Frazier at (954) 270-2125 and asked him to contact this agency to interview him about the harassing text messages. I also informed him to stop all communication with Fider.

Based on my investigation, I have found probable cause that Timothy Frazier has committed an act of stalking, pursuant to F.S.S. 784.048(2). This case has been filed with the State Attorney's Office.
