 On 10/18/2020 at approximately 1339hrs, Affiant observed a white/blue 22' Mako boat bearing FL3665JP / HIN: MRKF0654H495 traveling at a high rate of speed through a posted Idle speed zone located at the mouth of the Alafia River just west of 9425 41 Hw South Tampa, Hillsborough County, FL 33578 (citation #V374584). Upon stopping the vessel, affiant made contact with the defendant / operator. During personal contact with the defendant, affiant observed him to have blood shot watery eyes and detected a strong odor of an alcoholic beverage coming from his breath as he spoke. Based on this, Affiant requested the defendant perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the tasks. Affiant observed indicators of impairment and arrested the defendant for BUI. The defendant was advised Florida Implied Consent. The defendant stated he understood and refused to provide a breath sample. The defendant verbally identified himself and produced a Florida drivers license.
