The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 20 day of FEBRUARY, 2020,

at approximately 1:24 AM, at 2420 66TH TER S, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT: THE DEFENDANT WAS BREAKING OUT ALL THE WINDOWS TO HIS HOUSE, THROWING BEER BOTTLES OUTSIDE, AND YELLING SCREAMING AND CURSING IN PUBLIC VIEW. OFFICERS RECEIVED MULTIPLE CALLS TO THE DEFENDANTS ADDRESS FOR A DISTURBANCE IN WHICH GLASS WAS HEARD BEING BROKEN. CONTACT WAS MADE WITH THE DEFENDANT OUTSIDE OF HIS FRONT DOOR, DURING WHICH TIME HE APPROACHED OFFICERS IN AN AGGRESSIVE MANNER, AND THREW A BEER BOTTLE. THE DEFENDANT WAS DETAINED, BUT CONTINUED TO YELL SCREAM AND CURSE IN PUBLIC VIEW, RESULTING IN MULTIPLE NEIGHBORS COMING OUT OF THEIR HOUSES AND INTO THE STREET. DURING THIS TIME THE DEFENDANT WAS CLEARLY INTOXICATED WITH BLOODSHOT, WATERY, AND GLASSY EYES. ALSO HAVING A STRONG ODOR OF ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AND PERSON.

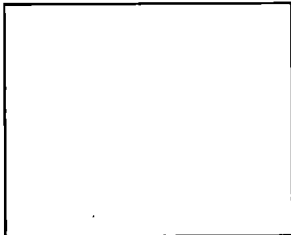
