The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did After responding to a 911 call for service, I located the defendant to be sitting in the driver seat of her blue 2017 Kia Forte (FL TAG #JNJC57). At the time, the vehicle was hanging out onto Angel Olivia Senior St N (formerly known as 18th St N), blocking an alleyway behind the James Joyce Irish Pub, not legally parked. The defendant was initially seen slumped over the center console armrest, however as I approached her driver door, the front seat passenger (a W/M) woke her up. Upon initial contact with the defendant, I observed her to have her car keys on her lap. She was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, largely dilated pupils, droopy eyelids, blank/dazed stare, slurred/slowed speech, very slow/deliberate movements, appeared sleepy/lethargic, was emotional, admitted to drinking alcohol prior to driving, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a display of 6/6 HGN + VGN and a refusal to continue with additional SFSEs. During her arrest, she was also found to be in possession of marijuana, a glass pipe and a grinder. While at CBT, she was read Implied Consent and refused to provide a breath sample.
