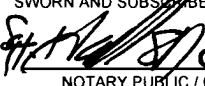

The following incident occurred in the City of Delray Beach, Palm Beach County, Florida. On 12/13/2021, Delray Beach Police Department (DBPD) Officer R. Lowry (ID # 977), responded to Harbor Freight Tools (1475 S Congress Avenue, Delray Beach), with regard to a theft. Upon arrival, Ofc. Lowry, met with Store Manager, Philip Scire. He advised that on 12/12/2021, at approximately 1130 hours, a W/F suspect (25-30 YOA, approx. 5`4, thin build, long brown hair, and a tattoo on her right shoulder), entered the store. She took two Jackery brand, Explorer 290 portable power stations (valued at \$249 each) from their display, and then placed them near the front door/exit. This brand of equipment is exclusively sold at Harbor Freight Tools, and cannot be purchased at any other retailer. She then exited the store, and moved her vehicle closer to the front door. The suspect reentered the store, took the two Jackery brand Explorer 290 power stations, and walked out, without paying, passing all points of sale. Video surveillance of the incident, was provided to Ofc. Lowry, by store management. Assistant Store Manager, Joshua Schuil (witness), was in the parking lot on a break, when he witnessed the suspect exit the store with the items. He saw her throw the items in to her vehicle, and then she quickly drove off. Schuil was able to write down the tag information (FL Tag DZGL40) of the suspect vehicle (gold Chevy Trax). The tag came back as a rental vehicle, through Enterprise car rental. On 12/14/2021, this case was assigned to me for follow up investigation. On that date, I contacted the Enterprise car rental law enforcement help line. They advised that the registered renter of the suspect vehicle (gold Chevy Trax, FL Tag-DZGL40), is Toni Lynne Cortina (W/F-DOB 9/20/1994). I also ran the tag, through the LINX database, and it showed that Cortina was given a traffic citation, in the same vehicle, by BSO, on 11/14/2021 (BSO Incident #0235323).

Cortina's physical description matched that of the suspect at Harbor Freight (W/F, 25-30 YOA, thin build, brown hair). I conducted a Facebook check, and discovered Cortina's personal Facebook profile "Toni Lynne" (https://www.facebook.com/toni.cortina). A photograph that she posted on 7/9/2019, shows that she has a round tattoo, on her right shoulder, which matches the location and shape of the tattoo, of the suspect on video surveillance. I ran a LEADSOnline search, using Cortina's information. LEADSOnline showed that on 12/12/2021, at approximately 1147 hours, she pawned two Jackery Explorer 290 power stations (new in box), at Crown Pawn (355 NE Spanish River Blvd, Boca Raton, FL). She received \$100 for each of the two power stations (\$200 total). These items were pawned shortly after the theft at Harbor Freight. This transaction was documented under transaction # BT-CPB002486. Per Mapquest, Harbor Freight Tools and Crown Pawn, are approximately 5.5 miles apart, with an approximate driving time of 10 minutes. On 12/15/2021, I went to Crown Pawn (355 NE Spanish River Blvd, Boca Raton, FL), and met with Anjelika Mikirtycheva. She provided me with the original pawn slip for transaction #BT-CPB002486. The pawn slip had Cortina's biographical information (name, DOB, address, FL DL #) as well as original right thumbprint and signature. I placed investigative holds on the items associated with the transaction. I also took photographs of each of the items, which were pawned in the transaction. The pawn slip states that "The Pledgor/Seller represents and warrants that the pledged/sold property is not stolen, rented or leased and that they have no liens or encumbrances against them." On 12/17/2021, Sgt. Gallina (ID # 881) and Det. Pitti (ID # 730), made contact with Joshua Schuil (witness) at Harbor Freight tools. Det. Pitti presented a photo lineup to Schuil, which consisted of six (6) photos (captured on BWC). One of the photos (photo #2) was a photo of Toni Lynne Cortina (offender). Schuil was able to positively identify photo #2, as the suspect who took the power stations and put them in her car. Schuil provided a sworn, witness statement (captured on BWC), advising of the same. On 12/17/2021, Latent Print Examiner CSI T. Tustin (ID # 163), identified the ink fingerprint on the original pawn slip from Crown Pawn, as the right thumb, belonging to Toni Lynne Cortina (W/F DOB 9/20/94). The identification was made by comparing the ink fingerprint on the form, to ink fingerprints obtained from the Palm Beach Sheriff's Office. Based on the above facts, I find probable cause to charge Toni Lynne Cortina (offender), with Theft- Retail (Shoplifting), pursuant to FSS 812.015(1)(D), Dealing in Stolen Property, pursuant to FSS 812.019(1), and False Owner ID-Pawned Items less than \$300, pursuant to FSS 539.001(8B)(A).
