The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed the defendant driving a gray Lexus with FL tag 59377Z on the roadway. He pulled out in front of me failing to yield the right of way. He was on the left side of the road and then turned left onto S. Howard Ave. He started to go forward then stopped in the roadway, blocking the lane of travel. I conducted a traffic stop and made contact with the defendant who was in the driver's seat and only occupant of the vehicle. Upon contact I could smell the odor of alcoholic beverages coming from his breath. His eyes were glassy and bloodshot. He said he had 3 Corona's.
