REASON REASON FOR STOP:

THE DEF WAS OBSERVED IN ACTUAL PHYSICAL CONTROL OF HER VEHICLE WHEN SHE WAS OBSERVED TO BE UNABLE TO MAINTAIN A SINGLE LANE AS SHE DROVE NORTH BOUND ON MCMULLEN BOOTH RD BY SGT. BAGINSKI. SGT. BAGINSKI INITIATED A TRAFFIC STOP AND OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY/GLASSY EYES, SLURRED SPEECH, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HER BREATH. THIS OFFICER ARRIVED ON SCENE AND OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY/GLASSY EYES, SLOWED SLURRED SPEECH, SWAYING BACK AND FORTH, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HER BREATH AND PERSON. 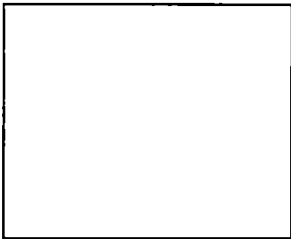
