The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the listed date and time, Corporal Dobson contacted the driver on a traffic stop for following too closely. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from his breath, he had slurred speech, he had bloodshot and watery eyes, and unstable balance. Field sobriety exercises were conducted and impairment was observed. The driver was arrested for DUI and refused breath test after Implied Consent warning was read and understood. A DAVID query revealed one prior refusal to submit to breath/urine/blood (Citation/Case #: 055272W) dated on 03/29/1997. In a Post-Miranda interview the driver stated he consumed a "6 pack" of Bud Light beers while at Jesse's Steak and Seafood approximately two hours prior to the stop. The driver was identified via DAVID.
